I understand that a condition of my being registered with ASA is that I will have no more than three students (short-term study tours are an exception) at any given time.

I understand that the information given above may be forwarded to a College, student, parent or education agent to provide them with information on the student's accommodation as part of their study in Australia. I agree that ASA can use my information only for this purpose and they are not to provide any information to any other person for any other reason.

I/We acknowledge that ASA accepts no responsibility in relation to Homestay placements and agree to release and discharge ASA from any action, claim, damages and or expenses arising out of this agreement. We recommend homestay families have adequate Homestay or Public Liability insurance to protect themselves and their property.

I/We understand that two weeks' notice must be given to ASA if you need to cancel a student placement.
